

Acknowledging access to justice is of critical importance, King County Superior Court (KCSC) leadership vowed to continue to hold matters on all case types, including jury trials, at the earliest time possible. With adapted operational procedures, new court technology, a public health plan, and legal community support, KCSC held over 300 jury trials, 1,000 bench trials, and countless hearings... Read more


