## Grantee Spotlight: Arizona Lawyer Apprentice Program (ALAP)



The [Arizona Supreme Court](#) implemented the Arizona Lawyer Apprentice Program (ALAP) on September 1, 2024, with generous grant support from the [State Justice Institute](#), creating an alternative pathway to law licensure. ALAP is designed for candidates who narrowly miss Arizona's Uniform Bar Exam (UBE) passing score of 270, recognizing that a single cut score does not perfectly measure attorney competence and future success. Rather than requiring these candidates to retake the UBE, ALAP allows those scoring between 260 and 269 to practice law under the supervision of an experienced Arizona attorney. Participants...
