National Summit on Human Trafficking

The National Summit on Human Trafficking and the State Courts was held October 7-9, 2015, in New York City. Each state sent a team made up of judges, court managers, and other key stakeholders, as appointed by that state's chief justice. The Summit was an overwhelming success, with teams from 46 states, 4 U.S. Territories, and the District of Columbia.

The first day was filled with expert panel discussions on human trafficking from the judicial perspective; labor trafficking; engaging stakeholders; and innovative strategies to address human trafficking by courts and communities. The second day included breakout sessions for state teams to work on their state court action plans for responding to human trafficking.

The state teams then reconvened to report back on the action planning and discuss their goals moving forward.

The Summit was hosted by the New York Unified Court System, under the leadership of Chief Judge Jonathan Lippman. The Conference of Chief Justices (CCJ), Conference of State Court Administrators (COSCA), National Center for State Courts (NCSC), New York State Bar Association, and the Women's Bar Association of the State of New York also partnered on this incredible event. Conservatorship Accountability Project Seeks Pilot States

Made possible through an SJI Grant, the Center for Elders and the Courts (CEC) at the National Center for State Courts (NCSC), has posted a call for states to become pilots for the CAP) (SJI-11-N-177). CAP aims to modernize conservatorship accounting and tracking processes and build safeguards to protect vulnerable adults from financial exploitation. A full synopsis of the CAP is available Online.

CEC invites state courts to apply to be one of three pilot sites that will receive free technical assistance from the NCSC. The application deadline is **Friday, December 11, 2015**. A selection panel will review applications and announcements will be made in January 2016. To be eligible for participation as a CAP pilot state, the following qualifications are required:

- 1. Submit application from the highest court of each state;
- Assemble a team of experts representing, at a minimum, a project manager, court technologists, business analysts, and guardianship/ conservatorship experts, and end user expertise from professional and/or private conservators;
- 3. Have the ability to pilot the software in the state within twelve months of the receipt of technical assistance;
- Have the capacity to integrate the software into the case management system. At a minimum, statewide conservatorship forms (e.g., budgets, audit forms, accountings) will be necessary to design the final software solution; and,
- Become founding members of the CAP Network and be willing to contribute to the development of a technical manual and an implementation guide.

APPLICATION: Applications are due by *December 11, 2015*. Applicants must provide contact information and must address the items listed on the following pages, which will serve as the basis for evaluation by the selection committee. The Background Information Form should be used as a cover sheet and does not count toward the page limit. The proposal itself should be *no longer than three single-space pages*. Signatures of the Chief Justice and State Court Administrator are required.

Through the CAP pilot, the state courts selected will receive resources to move their conservatorship case management closer towards implementation of a similar system. Courts interested in participating in the pilot, but not yet familiar with the MMC, may attend an online demonstration on Wednesday, November 4, at 12:00 CST. Guardianship Webinar Offers Ways to Improve Protocols and Practices in the State Courts



To help courts effectively handle the growing number of guardianship cases, the National Center for State Court's <u>Center for Elders and the Courts</u> developed a <u>webinar</u> that outlines specific steps courts can take to improve services.

The webinar, sponsored by the National Association for Court Management (NACM), based on its <u>Adult Guardianship Guide</u> — encourages courts to improve data collection and move toward performance measures.

Web Library for Cases Involving Immigrants
